


Regional economic cooperation and integration is key to ASEAN's future development strategy


- Pragmatic institutions and policies key components of success
- Outward-oriented, open approach to global economy central to ASEAN's economic clout
- Regional-level initiatives increasingly complement national level polices, helping drive ASEAN's global engagement
- Regional cooperation and integration must be addressed and managed systematically
- Natural for ASEAN to look upon Europe as global benchmark on regional integration—both for what went right and what didn't

Beginning with trade integration



ASEAN integration is deepening...

- Trade: tariffs for most traded goods within ASEAN between 0 to 5 %—internal ASEAN trade \$434 billion in 2007 (\$181 billion in 2000)
- Investment: Rebound in FDI since 1997/98 financial crisis—2006 FDI inflow to ASEAN **\$51** billion (\$24 billion in 2000)
- Finance: Cross-border capital flows within ASEAN-5 expand—\$28 billion in 2006 (\$12 billion in 2001)

...due to pioneering initiatives

- Spearheaded Asia's first efforts at regional economic integration
- Despite political, economic, cultural diversity, ASEAN created a structured regional dialogue
- Substantial tariff reduction and first regional free trade area in Asia
- Open regionalism e.g., voluntary multileralization of tariff reduction
- And, of course, the new Charter gives ASEAN legal status and moves it toward a more rulesbased regional institution


Building the AEC is crucial for futureAsian Integration...

For ASEAN to be an effective "driving force" for Asia, it needs to further deepen its own integration:


- reduce transaction costs
- enhance investment climate
- improve trade and "Doing business" parameters
- upgrade private sector competitiveness; and
- strengthen the institutional structure including dispute settlement mechanisms

AEC vs. EU: What's different?



AEC vs. EU: What's different?The four "S"s

- Sequence: Freer capital flows means financial integration in tandem with trade, not afterward as in Europe
- Style: Cultural, social, and political diversity works against regional institutions to absorb national sovereignty
- Scope: Most practical for ASEAN integration—a multi-track, multi-speed approach firmly anchored on subregional integration
- Speed: ASEAN likely to benefit more from an "open method" of cooperation and coordination instead of European "community method"

Making the AEC work: issues and challenges

- How to close the development gap within ASEAN
- The AEC budget and how to finance it
- ASEAN Secretariat (ASEC) funding is hampered by the equal annual contribution scheme
- Institutional support for AEC implementation remains weak



How to build the capacity to bridge the ASEAN development gap?

- Aid-For-Trade (AfT) can help ASEAN tackle the development gap
- Alternative schemes are needed to finance the operations of ASEAN Secretariat
- Vibrant and integrated capital markets can build regional financial stability and better allocate resources
- Subregional cooperation programs such as GMS, BIMP-EAGA, and IMT-GT can help fast track integration

How does ADB fit in?

- MOU and joint work program with ASEAN Secretariat
- Helped AEC Blueprint and ASEAN Charter
- Training on FTA negotiations, financial programming, and macroeconomic surveillance
- Helps ASEAN Secretariat monitor AEC implementation
- Supports the ABMI on regional and local currency bond markets
- Internal realignment to serve ASEAN better; and
- RCI Strategy supports ASEAN as driving force for Asian economic integration.
